**Commissioner Meeting**

June 2, 2010

President Faust called the meeting to order

The Pledge of Allegiance was said

In attendance were President Faust, Commissioners Price, Engrem and Ford. Also In attendance was Clerk /Treasurer Nicole Hilliard

Commissioner Price made a motion to approve previous minutes from May 19, 2010, seconded by Commissioner Engrem, Approved 4-0

**Reports**

The Sheriff's Department reported on the last month's calls to the town, along with the status of enforcing the use of engine breaks in town. They will continue to work with the town in reducing the infractions.

Commissioner Ford reported on the planning commission. Commissioner Engrem requested that copies of the Planning Commission minutes also be sent to the Commissioners

Commissioner Price expressed his concerns that Chris Frawley from Rettew has not been communicating with the Commissioners regarding meeting with contractors.

**Action Items**

President Faust made a motion to accept the redrafting of the grass mowing letter as presented by Commissioner Price, Commissioner Engrem Seconded the motion. Approved 4-0

President Faust reported the Calvin Embert is in need of a new push broom, paint pail and a chain saw, as he has been using his own chain saw for town work. The commissioner agreed that the town should make those purchases and to find out what size chain saw that he needs.

Commissioner Price made a motion to use any leftover monies from the FEMA reimbursement from the December and February snow storms to buy a snow blower for use on the town sidewalks.  
Commissioner Ford seconded the motion. Approved 4-0

President Faust made a motion to adjourn into executive session to discuss employee matters.  
Seconded by Commissioner Engrem.

President Faust reconvened the meeting upon completion of the Executive Session.

He announced that the Commissioners had considered an individual pay raise and determined that a general increase in the form of a bonus would be more appropriate and a final determination would depend on the budget.

Commissioner Price moved to adjourn, Commissioner Engrem seconded.
